
Scope of Audit and Basis of Opinion



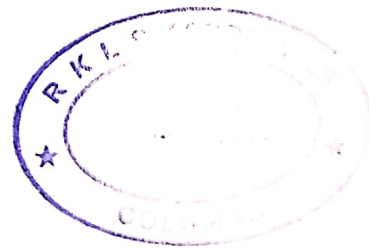

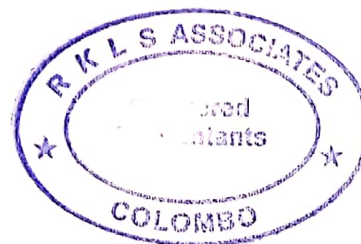
